## 2. Inclusion in the <u>"Educational guidance competence check"</u> project

- The advisor creates your personal competence profile and you work together on a career plan for implementation.
- This gives people with language level A2 and formal/informal competencies the option to participate in the course "Competent in the Future - Professional Training in German with Competence Check".

# 3. (If required) Participation in the course <u>"Competent in the Future - Professional Training in German</u> with Competence Check" (with course provider)

- Attendance at a German course with level B1 including internship opportunities and
- practical testing of formal and informal competencies through training centres.
  - So far, practical testing has been carried out in the areas of IT (office applications, Photoshop, AutoCAD, hardware), photography, office/administrative activities, accounting, sales, tailoring, hairdressing, cosmetics, gastronomy (service/bar/kitchen/baking), electrical engineering, painting, metalworking, welding, construction (bricklaying, formwork), tiling, cars and carpentry.

4. <u>Summary</u> of the competencies acquired through the IAM consultant and <u>support</u> with labour market integration and search for suitable training and continuing education.
